# **November meeting minutes**

Meeting was called to order at 7pm. Don Bourdon presided in the absence of Seth Nagy. Neither Seth (President) nor Brett Springall (Secretary-Treasurer) could attend the meeting. Don asked Jackie Nagy to take minutes of meeting.

Eight members and two guests were present. Meeting agenda was presented by Don. Vic Welland asked to add January pylon race to the new business section. Ron Miller made a motion to accept the proposed agenda; Bliss Teague seconded the motion.

Scott Austin presented his application for CAM membership. Also present was Dave Groome, who has completed his application for membership but forgot to bring it to the meeting. All present were in favor of accepting both as new members.

Minutes of the October meeting were brought forth. Bliss made motion to accept minutes; Ron seconded the motion.

Treasurer's report was sent to Don by Brett. Club treasury balance is \$1647.50, indicating no changes since last meeting. It was noted that \$65 for the auction of the plane (donated by Planes, Trains & Automobiles) at October meeting has not yet been posted to our account. Don is to be paid for the t-shirts & printing fees also.

On that subject, Don announced that our CAM t-shirts have arrived. Sizes Small – XL are \$10; XXL are \$12; XXXL are \$14. (Don paid for shirts & printing fees. Club is reimbursing Don.) Jack Adams could not attend, so no field report was given. Vic noted that new pins and the Gold Leader Club signs are now available at the field. New orange pins are for 2.4 frequency users.

Intro Pilot report was given by Vic, who presented a "First Solo Flight" certificate to Steve Abee. Congratulations, Steve, for soloing before the Christmas deadline you had given yourself!

Other old business included the Runway/Field Improvement Committee suggestions. This past summer, several members brought forth suggestions for improvements to the flying field. Vic distributed a hand-out of those suggestions to be discussed in the new year.

#### New business

Our December meeting has typically been a Christmas party during which we conduct very little club business. Instead, we will have food & fellowship with club members & their families.

Before adjournment of meeting, Vic brought forth the

Quickie 25 pylon race, which is to be held at the CAM field on January 31, 2009. It will be a 2-pole race with (hopefully) about 15 racers from NC & SC participating. Vic listed several jobs that need to be filled in order to hold the race: starter, scorekeeper, flaggers, timers, corner judge, photographer, sign-in table clerk, impound table worker, sign placement person. If you want to help with this event, please let Vic know. Vic also asked if club could pay for race awards for 1st, 2nd, and 3rd place winners. Ron made motion for club to allow up to \$50 for these race awards; Bliss seconded the motion. No one in attendance opposed.

Vic also asked for all members' radio frequencies so he can create a frequency roster for the club.

There will also be a work day at the CAM field on December 6 at 9AM. Runway needs to be patched, trees need to be cut. Rain date for work day will be December 13.
